

A Letter to Members from Our President

Dear Members and Friends,

When I was elected President of the Society ten months ago, Gary O'Malley, our new Executive Director, and I identified three key goals for 2010. In addition to ongoing work on existing programs which support the Society's mission, such as negotiating and pursuing funding for scenic easements in the Sawtooth NRA and educating landowners about the content and importance of the area's Private Land Regulations, we hoped to:

- Increase the Society's visibility and membership - particularly in areas outside the Sawtooth Valley where many regular visitors and users of the Sawtooth NRA reside;
- Expand member involvement in Society programs and affairs, especially in leadership roles; and
- Increase and strengthen our partnerships with other entities which positively impact the Sawtooth NRA for the benefit of all who live or visit there. I believe we have made important progress in all three areas.

To foster membership growth and increased visibility, we held three outreach/development events, two in the Wood River Valley and one at Smiley Creek, attended by over 150 people. In 2010, we hope to host similar events in Boise and Twin Falls. The Society also received very favorable media coverage in two new publications: the Twin Falls Times Mirror and Sun Valley Magazine. I have no doubt these efforts contributed to our new member growth and rekindled interest and enthusiasm among long-time supporters.

In May we held another Sawtooth Vision 20/20 Workshop in Stanley,

bringing a number of new participants into this on-going undertaking, and in August the Society's Annual Board Meeting was, for the first time, opened to all members. In addition to providing some very constructive feedback, these steps resulted in both new ideas and additional individuals to help implement the actions recommended in the 20/20 Long Range Plan and other Society activities.

At the Annual Meeting, we also agreed to expand the Executive Committee from four to seven members. We now have the talent and experience of Bob Haves as Immediate Past President, Hans Carstensen as Vice President -New Initiatives, Michael Humphreys as Vice President - Lands Programs, Reuben Perin as Vice President -Member Development, Patricia Young as Secretary and Keith Reese as Treasurer. Working with Gary, I believe our expanded Committee will provide the leadership, resources and expertise to make the Society's programs more successful than ever. And, to further enlarge our leadership team, we plan to add four very capable and energetic new Board members this winter

The number and scope of our partnerships, working to carry out various aspects of the Society's mission, grew as well.

- Two new motorized trail rider groups are joining our pilot program to establish authorized, appropriate, and clearly identified OHV trails in the Pole Creek area. These actions would also close unauthorized user created trails and increase education and enforcement on OHV trails where riding is not appropriate.
- The Trust for Public Lands has linked

with the Society to hopefully help secure permanent scenic easements on large and highly visible land parcels in the Stanley Basin.

- The City of Stanley and the Stanley-Sawtooth Chamber are working with the Society to establish an improved permanent year round trail for hikers, bikers, skiers and snowmobilers from Stanley to Redfish Lake; to construct a new, user friendly Visitors Center in Stanley; and to increase affordable housing in and around Stanley.
- And, we welcome our newest partner, Sun Valley Adaptive Sports, with whom we are working to improve opportunities for those with disabilities to enjoy the Sawtooth NRA's recreational facilities.
- Existing partnerships with other important entities such the Forest Service, Idaho Fish and Game, Idaho Department of Parks and Recreation and the Sawtooth Interpretive & Historical Center also continued to grow in new directions.

Finally, I am gratified to report that, despite the economic challenges faced this year, we expect to end 2009 in a substantially stronger financial position than a year ago. For this, I sincerely and gratefully thank our supporters as well as each of you. Without your continuing support, and the financial resources thus provided, the Society would not be able to carry on, much less grow, our efforts to protect, preserve and enhance the Sawtooth NRA for everyone.



State of Idaho / U.S. Forest Service Land Exchange

Most of you remember the controversy created by the State of Idaho Transportation Department when it initiated mining gravel on a highly visible parcel of land in the Fourth of July Creek area in the summer of 2006. That parcel is one of four owned by the State that lies within the boundaries of the Sawtooth National Recreation Area (SNRA). These parcels are legally unencumbered by the regulations and principles established by PL 92-400, the law that created the SNRA. Thus, the State of Idaho is under its normal constitutional mandate on these parcels to maximize their financial return to benefit the citizens of Idaho.

The rub comes when this financial focus conflicts with the scenic, historical and pastoral values which have been firmly established over the last three decades on the other lands within the SNRA. In this case the conflict came to a head as the Idaho Department of Transportation began the gravel extraction on a long-term mining lease it had obtained from the Idaho Department of Lands, the manager of these four state parcels. As a result, many recreational users, neighbors and visitors were upset with these actions, which they considered incompatible within the SNRA.

Since 2006 the Sawtooth Society has helped foster discussions between the

State of Idaho and the U.S. Forest Service to find an agreeable way to transfer these four parcels from the state to the federal government. A key element of this work is finding an acceptable source of gravel for the state to use for road surfacing. The first chapter of this work included the possibility of a threeway land exchange involving the Tamarack development. However, that development's financial challenges have required that discussions begin anew, looking at other options to consummate an exchange.

While exchanges of this magnitude often take up to a decade to complete, the parties continue to believe it is in everyone's best interest to find a long-term solution to this thorny issue. This land exchange is and will remain a top priority for the Sawtooth Society to help resolve by:



- Acting as a catalyst to bring the parties together to seek creative and long-term answers.
- Keeping the media, Congressional Delegation and the Governor's Office and other stakeholders apprised of progress.
- Investing time and other resources as necessary to overcome hurdles to a successful exchange of the state-owned lands within the SNRA to the U.S. Forest Service.
