By signing below, I acknowledge, understand, and agree to the following:

1. This Release applies to my participation in the Sawtooth Society's Volunteer Trail Stewardship Project near Stanley, Idaho. The project is scheduled for _____, and includes, without limitation, possible overnight accommodation at Crooked Creek Ranch, owned by Hans and Terry Carstensen, activities incidental or related to the project, and transportation to and from the project location (hereinafter collectively referred to as the "**Stewardship Project**"). I acknowledge that participation in the Stewardship Project includes physical activities. In spite of care, precaution and concern, accidental injury may occur by the very nature of the such activities. I have conducted such inquiries as to any and all activities to be undertaken as part of the Stewardship Project and/or made such inquiries regarding the Stewardship Project as I deem necessary to satisfy myself that all such activities and the facilities and equipment related thereto are safe and reasonably suited for my use and participation.

I hereby release, waive, discharge and agree not to sue the Sawtooth Society, Hans and Terry Carstensen, and the US Department of Agriculture – Forest Service, and any directors, officers, employees, representatives and agents of same (hereinafter referred to as the "**Releasees**") from and for any and all liability to me and/or my personal representatives, assigns, heirs and next of kin for any loss, damage, claims or demands related to my participation in the Stewardship Project (collectively "**Released Claims**"). The Released Claims include but are not limited to, any loss, damage, claims or demands for personal injury, property damage, death, punitive or exemplary damages, or other losses arising out of or relating to my participation in the Stewardship Project, whether cause by Releasees' negligence, gross negligence, willful conduct or otherwise.
3. I agree to defend, indemnify, and hold harmless Releasees from any and all claims, suits, losses, liabilities, damages or costs asserted against Releasees or that Releasees may incur arising out of or related to my participation in the Stewardship Project, whether caused by the negligence, gross negligence, willful conduct, or otherwise of Releasees.
4. I assume full responsibility for and risk of bodily injury, property damage, or debts arising out of or related to my participation in the Stewardship Project, whether caused by the negligence, gross negligence, willful conduct or otherwise of Releasees.
5. I intend and agree that this Release is as broad and inclusive as permitted by applicable law, and if any portion thereof is held invalid, I intend and agree that the balance shall continue in full legal force and effect.
6. This Release is given in further consideration of Releasees' agreement to allow me to participate in the Stewardship Project.
7. I also hereby give the Sawtooth Society permission to publish images of myself for purposes of promoting the Sawtooth Society and/or Austin Kraal Memorial Volunteer Program in any medium.

I have read this Release, Waiver of Liability and Indemnity Agreement. I understand the rights I am giving up by signing it.
